IMPORTANT NOTICE

I, by my signature on this document indemnify the BCB, its committee, agents, representatives and members against any claim instituted against them, whether jointly or severally or both, by any third party, and hold such persons harmless in respect of any claims instituted by such party, whether based in delict or contract, arising out of my participation in BCB activities.

The Bureau committee reserves the right to terminate the membership of any member who does not abide by the rules of the Bureau.

I, accept that should myself or my family or any guest of mine, cause any loss or damage to a farmer's or landowner's property or stock, it will be my responsibility and not that of the Bushveld Conservation Bureau.

I will therefore have public liability insurance to cover any loss, damage or injury to the farmer, landowner or anyone else in the vicinity by myself or my party whilst conducting legitimate BCB activities. I am also fully aware in that should any injury or loss occur to myself or my family or my guests whilst on a Bureau farm, I shall have no recourse or claim on Bushveld Conservation Bureau as I have accepted the methods and regulations under which the Bureau organises hunting trips or visits to these farms.

The following are among the regulations of Bushveld Conservation Bureau:

1. No member may visit a BCB acquired farm at any time without a prior booking being made with the farm booking manager.
2. No member may shoot an animal species that does not appear on the letter of permission for that particular farm.
3. No member may shoot a game species on a BCB acquired farm outside of the promulgated open season for that particular species in that particular area.

I UNDERSTAND THAT MY MEMBERSHIP OF BCB MAY BE REVOKED WITH IMMEDIATE EFFECT IN THE EVENT THAT I TRANSGRESS ANY OF THE BCB REGULATIONS.
